This will acknowledge receipt of your request for victim notification received today requesting to be notified of the escape, death, court or mandatory supervision release of Donald Brunstetter.

You will be provided written/phone notification of the inmate's escape, court or mandatory supervision release from the Division of Correction in compliance with Criminal Procedure Article, §11-1002. This notification will include the inmate's full name, address upon release, social security number, a recent photograph of the inmate and a brief description of the offense. Since this inmate is a convicted child sexual offender, the Division of Correction will register this inmate as a child sex offender prior to his release from incarceration.

Enclosed is a VINE pamphlet advising of your option to participate in the VINE system. This service allows for automated telephone notification. **You are not automatically registered.** If you choose to participate in the VINE system, please follow the directions provided in the pamphlet.

Donald Brunstetter was admitted to the Division of Correction on 8/27/2008 and is assigned Division of Correction identification number 352546. This inmate currently incarcerated at the Md. Correctional Training Center.

It may be possible for the inmate to be parole released, therefore a copy of your request is being forwarded to the Maryland Parole Commission.

Also, Criminal Procedure Article 11-1002(b)(15), Annotated Code of Maryland, requires that a victim, on written request to the Division of Correction and Parole Commission, may have a victim impact statement read at any hearing to consider temporary leave status or a provisional release. If you wish to submit a request, please forward a copy to this office.

Please advise this office of any change in your notification information or if you no longer wish to be notified. When writing to this office, it would be helpful if you would include this inmate's identification number.
